**Following is the second report on seven leading industrial unions with membership who strongly support the Trump-Vance agenda, but whose leadership have abandoned the will of their membership and taken on a heavily liberal partisan lean. This report focuses on the Laborers' International Union of North America.**

When President Trump secured the Republican nomination in 2016 and then subsequently defeated Hillary Clinton, he completed a fundamental re-alignment of the Republican Party's policy agenda and its electoral base. The President's re-alignment endured through the Biden election in 2021 and through the President's re-election in 2025. A crucial part of the President's re-alignment of the Republican Party was his focus on issues that were vital to blue-collar workers, particularly immigration enforcement and adjustment of the U.S. trade regime through preference for bilateral agreements and the willingness to use tariffs as a tool of trade and domestic policy. At the center of the President's base was the working-class men without college degrees, many of whom were members of industrial unions.

While the broad support for the Trump-Vance agenda by industrial union members has been widely reported on, news of this nearly decade old re-alignment has apparently yet to reach the leadership of the Laborers' International Union of North America, whose dues-paying members repeatedly cast ballots for President Trump.

LIUNA is a union with over 500,000 members in the United States and Canada. LIUNA's leadership has consistently aligned itself with far-left political actors and rhetoric that openly undermine law enforcement and federal authority, giving labors voice to a progressive movement far outside issues that relate to labor concern. Through their endorsements and coordinated social media messaging, LIUNA leadership has positioned the union as a leading antagonist in the fight against President Trump rather than as a representative of its members' interests.

LIUNA Union leadership has repeatedly condemned Immigration and Customs Enforcement (ICE) for conducting lawful federal activities. Their messaging has framed enforcement actions as abusive and illegitimate. LIUNA official statements have called for ICE to leave Minnesota and have echoed rhetoric portraying federal law enforcement as an invading force rather than a lawful authority. Unsurprisingly, LIUNA endorsed Minnesota Governor Tim Walz

Politically, LIUNA leadership has shown unanimous loyalty to Democratic presidential tickets. In the last two elections, they have supported Biden-Harris and then Harris-Walz. While doing this, they have maintained what borders on an obsessive opposition to the Trump-Vance agenda. Union leadership has used official union platforms to attack Trump's economic and labor policies. Criticism and attacks by LIUNA leadership against the President Trump have been a constant feature since he entered the political scene.

LIUNA's political alliances include the most outspoken critics of President Trump, including Bernie Sanders, Cory Booker, Raphael Warnock, and Hakeem Jeffries. These individuals have attacked the President incessantly and have characterized him as an authoritarian and morally corrosive.

Several members of LIUNA's executive leadership have consistently donated to Democratic campaigns and causes. This pattern echoes the pattern of LIUNA political donation funds being almost exclusively allocated to leftist groups and candidates. Over 96% of the more than \$13 million in their federal political spending has gone to Democrats.

To make matters worse, leadership has personally benefited from members' dues and payments. LIUNA members, on average, make a salary of around \$50,000. The pay discrepancy between the average LIUNA member and their leadership is shocking. 37% of LIUNA headquarters staff earns over \$200,000 per year. 62% over \$100,000, and the general president and secretary-treasurer each earn over \$600,000 a year. Financially, the extravagant salaries of LIUNA leadership are only eclipsed by their astronomical spending on entertainment. Union leadership has shown an affinity for motor racing. Since 2017, LIUNA has spent an outrageous \$10 million on racing events. Those eight figures spent on such events could have been spent on training and career furthering opportunities for their members. Instead, LIUNA wastes its members' dues on racing.

The mountains of wasteful spending do nothing to help everyday union members. There is a blatantly liberal agenda that is pushed by LIUNA's leftist leadership that does not reflect the values of its base. This agenda is pushed by the very leaders who live extravagantly off the backs of their hard-working members.

## Methodology

### Sourcing

Spending from LM-2 forms were sourced via the Office of Labor-Management Standards payee/payor search. All entities (locals, regional councils etc.) for each union were combined into one spreadsheet to detail spending from 2017 to 2024. All spending for PACs and Independent Expenditures were gathered from the Federal Election Commission.

### Political Spending

Unlike most organizations, owing to their history of corruption, many labor unions are subjected to a much more extensive public disclosure requirement regime than most not-for-profit organizations. The chief disclosure mechanism for unions is the LM-2 form that is required by the Office of Labor-Management Standards. This form requires detailed reporting of line-item expenditures from the union, detailing nearly all expenditures by the union. In the reporting below we will detail political expenditures from the union both as detailed in their LM-2, and as detailed with the Federal Elections Commission for hard dollar political donations from their PACs and Independent Expenditures. We also detail political expenditure from the union's LM-2 that are political/advocacy in nature, including advocacy and political activities that are not necessarily tied to a registered political committee, but are clearly designed to influence public debate.

### Wasteful Spending

We have compiled the LM-2 forms for all seven unions from 2017-2024 (last available year for all unions). 2017 was used as it marked the beginning of President Trump's first term. The disclosure of union spending on these forms is broken down under five categories that include general overhead, union administration, representative activities, contributions/gifts/grants, and political activity. These spending categories (golf outing as general overhead) are often misleading, so we have created seven new classifications that more accurately describe union spending. New categories for spending are listed as follows, entertainment, food and beverage, hotel and conference, legal, political spending, swag, and travel.

#### *Categories*

**Entertainment** – Parties, amusement parks, recreational events/activities, as well as sports ventures and venues

**Food and Beverage** – Restaurants, drinks, fast food, and catering

**Hotel and Conference** – Resorts, hotels, conferences, banquets, and event venues

**Legal** – lawyers, law firms, arbitration, and any legal expenses

**Political Spending** – Advocacy, ideological organizations, candidates, committees and all expenses the union labels as political activity

**Swag** – Watches, jewelry, t-shirts, gifts, printing, and any merchandise purchased by the union

**Travel** – Airlines, travel expenses, and travel agents



## Political Spending Undermining MAGA Policies

One of the clearest examples of LIUNA's blatant leftist positioning lies in their political spending. When inspecting where their political donations go, it becomes clear that they are operating as a de facto left-wing group. Whether it is hard dollars, the union's treasury, or independent expenditures the bias is overwhelmingly progressive.

### Nearly \$200,000,000 in Political Spending

LIUNA spent nearly \$200,000,000 on political spending from 2017 to 2024.<sup>1</sup> Most of this money went to LIUNA associated PACs and advocacy organizations (LIUNA Political Fund, LIUNA Chicago Laborers District Council PAC) and other labor advocacy organizations.

The union also spent money on left-wing candidates and groups like Jobs for Justice and the Dolores Huerta Foundation.

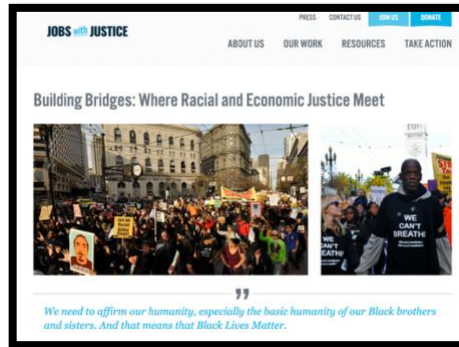

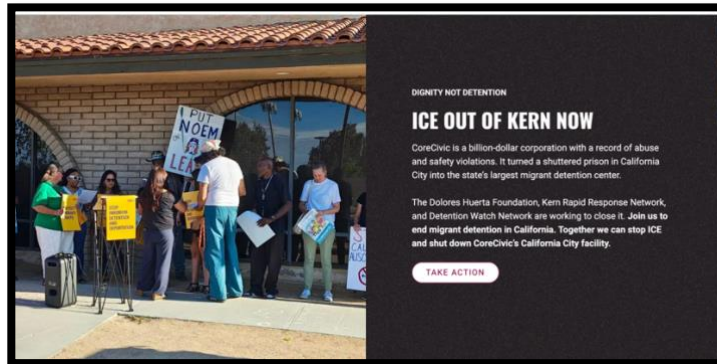

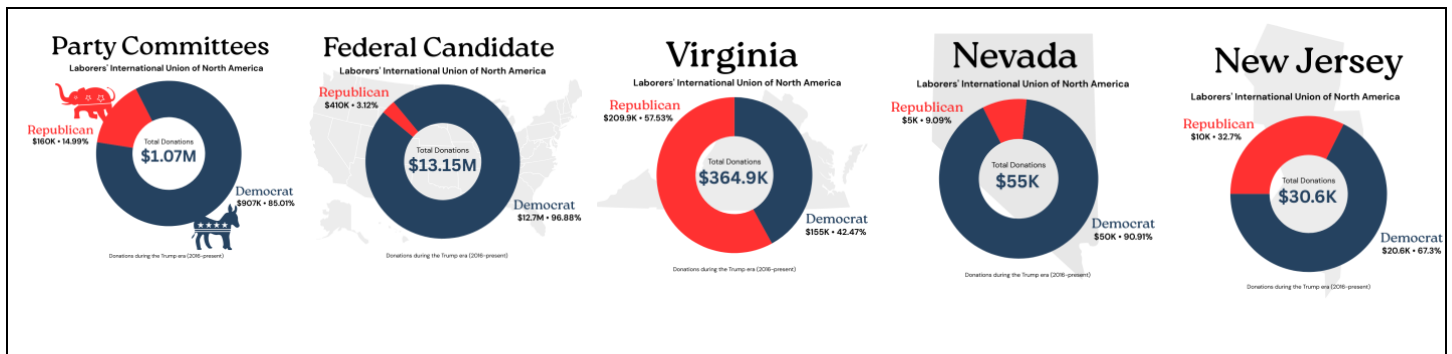

The Dolores Huerta Foundation opposes the Trump-Vance immigration agenda and has denounced ICE.<sup>4</sup>



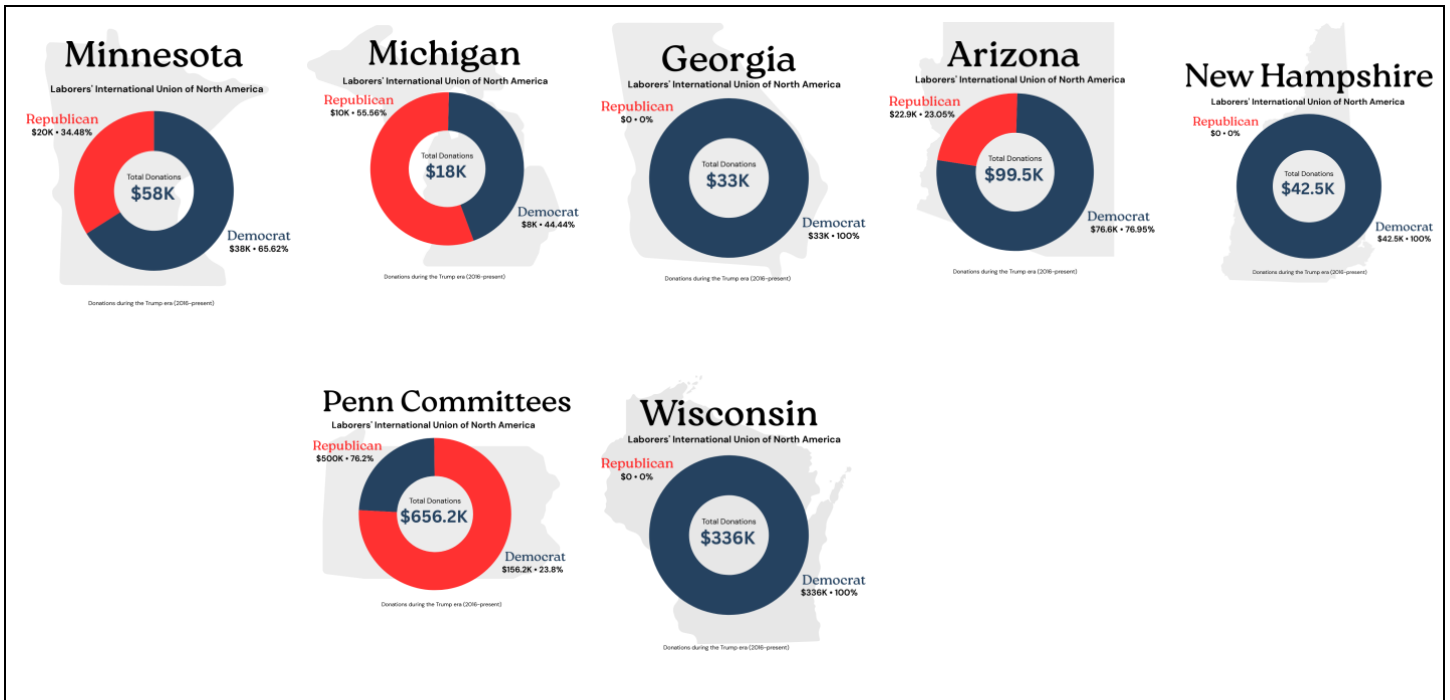
**LIUNA Hard Dollar Spending Overwhelmingly Favors Democrats**

The Laborers’ International Union of North America Political Action Committee does not operate as a politically neutral labor organization. During the analyzed period, its hard-dollar program functions in practice as a reliable funding vehicle for Democratic candidates and Democratic political infrastructure. The scale, consistency, and concentration of the spending leave little ambiguity about its partisan orientation.

LIUNA directed \$907,623.38 to Democratic party committees compared to \$160,000.00 to Republican committees. That means 85.01% of party committee dollars went to Democrats and just 14.99% to Republicans. Even this disparity understates the larger pattern, because the committee category includes both federal and state activity. The real concentration becomes unmistakable at the federal candidate level.

At the federal candidate level, LIUNA contributed \$12,739,000.00 to Democratic candidates and only \$410,500.00 to Republican candidates. That represents 96.88% of federal candidate dollars flowing to Democrats and only 3.12% to Republicans. Put differently, for every dollar LIUNA directed to a Republican federal candidate, more than thirty dollars went to a Democrat. The federal allocation pattern alone determines the PAC’s political posture.

There are limited state-level deviations in narrower categories. Virginia and Michigan, for example, show Republican advantages in isolated contexts. But those instances are numerically insignificant compared to the federal totals. The overwhelming majority of high-dollar spending occurs at the national level, and at that level, the orientation is nearly uniform. The few deviations do not moderate the trend. They highlight it. The imbalance is structural, not incidental.

The aggregate totals are reinforced by the PAC's largest disbursement targets. LIUNA's largest checks went to core Democratic leadership infrastructure, including House Majority PAC, Senate Majority PAC, and the Democratic Senatorial Campaign Committee. These are not transactional contributions tied to individual local races. They are institutional investments in maintaining and expanding Democratic congressional control. The scale of these disbursements confirms that LIUNA's political strategy is aligned with national Democratic leadership priorities.

- SMP (a.k.a Senate Majority PAC) received \$11,750,000.00;<sup>6</sup>

Taken together, LIUNA’s hard-dollar activity is not meaningfully bipartisan. The concentration of federal candidate spending and the overwhelming share of committee dollars directed to Democratic entities reflect a sustained and deliberate partisan allocation strategy.

***LIUNA Independent Expenditures Reflect the Same Partisan Pattern***

LIUNA reported \$1,755,818.55 in independent expenditures during the analyzed period. All reported independent expenditure spending supported Democratic candidates or opposed Republican candidates. There were no reported independent expenditures supporting Republican candidates or opposing Democratic candidates. The directional consistency between hard-dollar contributions and independent expenditures underscores a uniform political allocation strategy.

**LIUNA Executive Board Donations**

Several General Executive Board members at LIUNA have consistently made donations to leftist politicians and groups. Several examples are provided.

Despite LIUNA members making an average salary of around \$50,000,<sup>12</sup> 37% of LIUNA's national headquarters employees earn a salary over \$200,000 a year. 62% of the national headquarters earns a salary over \$100,000 and the general president and secretary-treasurer make over \$600,000 a year.<sup>13</sup>
