Report Three – SMART – Transportation Division (International Association of Sheet Metal, Air, Rail and Transportation Workers – Transportation Division)

Following is the third report on seven leading industrial unions with membership who strongly support the Trump-Vance agenda, but whose leadership have abandoned the will of their membership and taken on a heavily liberal partisan lean. This report focuses on the SMART – Transportation Division (International Association of Sheet Metal, Air, Rail and Transportation Workers – Transportation Division) union.

When President Trump secured the Republican nomination in 2016 and then subsequently defeated Hillary Clinton, he completed a fundamental re-alignment of the Republican Party's policy agenda and its electoral base. The President's re-alignment endured through the Biden election in 2021 and through the President's re-election in 2025. A crucial part of the President's re-alignment of the Republican Party was his focus on issues that were vital to blue-collar workers, particularly immigration enforcement and adjustment of the U.S. trade regime through preference for bilateral agreements and the willingness to use tariffs as a tool of trade and domestic policy. At the center of the President's base was the working-class men without college degrees, many of whom were members of industrial unions.

While the broad support for the Trump-Vance agenda by industrial union members has been widely reported on, news of this nearly decade old re-alignment has apparently yet to reach the leadership of the SMART – Transportation Division (International Association of Sheet Metal, Air, Rail and Transportation Workers – Transportation Division) union whose dues-paying members repeatedly cast ballots for President Trump.

SMART is the largest railroad operating union in North America and is made up of over 700 local unions and 230,000 members across the United States, Canada, and Puerto Rico.

Despite a wide swath of Trump supporters in its membership ranks, SMART has consistently aligned itself with left-wing organizations and candidates. SMART leadership has even criticized its members for "ignoring" the failings of President Trump. The disregard for its membership is evident by a myriad of criticisms the union has levied at the Trump Administration and its allegiance to Democratic candidates. Unfortunately, SMART's failures don't end with its political alignment, the union has wasted millions of

dollars on everything from swag to entertainment and even employs a criminal with a racist history in leadership.

SMART's anti-MAGA agenda dates all the way back to 2016, when it endorsed Hillary Clinton for president. The union went on to endorse Joe Biden in 2020 and Kamala Harris in 2024. Additionally, SMART has taken a strong stand against the Trump Administration's policy on deporting illegal immigrants. In 2025, SMART president Michael Coleman appeared on CNN to defend MS-13 gang member, Kilmar Abrego Garcia. Coleman opposed the Trump Administration's attempts to deport Garcia and even claimed there was no evidence of his gang affiliation. The union has often criticized the Trump-Vance agenda while praising the Biden Administration.

SMART has backed up its left-wing bona fides with money from its PACs and its members union dues. From 2017-2024, SMART spent over \$35,000,000 in union funds that heavily favored Democratic groups and allies with no spending on any right-of-center organizations. Some of this spending went to Democratic committees and racial/economic activist organizations like Working Partnerships USA and the Blue Green Alliance. The union's PAC and Independent Expenditure reports also heavily benefit Democratic committees. From 2016 to present, The IA-SMART PAC contributed just over 97% of its party committee and federal candidate disbursements to Democratic committees while just under 3% went to Republicans committees. While SMART's independent expenditure activity for the same time frame only totaled \$165,000.00, all of this went to supporting Democratic candidates and opposing Republicans.

Despite its contributions to left-wing racial justice groups, SMART is currently employing a career criminal as a senior vice chairman. The union officer in question is Zachary Nagy, a man who has previously been charged with disorderly conduct, criminal discharge of a firearm, theft, aggravated robbery/kidnapping, criminal deprivation, aggravated assault, violation of civil rights, and conspiring against the rights of citizens. Most notably, Nagy notably served 30 months in prison for terrorizing a black family by burning a cross in front of their residence in his home state of Kansas.

SMART not only does a disservice to its members when it comes to politics and its choice in leadership, it has also squandered member dues on a wide swath of waste from swag to entertainment. This spending includes millions of dollars that went to theme parks, sporting teams, and golf events as well as over \$10,000,000 on casinos and resorts. Despite this egregious spending, the union still managed to find over \$400,000 to pay the salary of its left-wing general president, Michael Coleman.

SMART membership deserves better than what they are getting from the self-serving partisan leadership that currently runs the union.

Methodology

Sourcing

Spending from LM-2 forms were sourced via the Office of Labor-Management Standards payee/payor search. All entities (locals, regional councils etc.) for each union were combined into one spreadsheet to detail spending from 2017 to 2024. All spending for PACs and Independent Expenditures were gathered from the Federal Election Commission.

Political Spending

Unlike most organizations, owing to their history of corruption, many labor unions are subjected to a much more extensive public disclosure requirement regime than most not-for-profit organizations. The chief disclosure mechanism for unions is the LM-2 form that is required by the Office of Labor-Management Standards. This form requires detailed reporting of line-item expenditures from the union, detailing nearly all expenditures by the union. In the reporting below we will detail political expenditures from the union both as detailed in their LM-2, and as detailed with the Federal Elections Commission for hard dollar political donations from their PACs and Independent Expenditures. We also detail political expenditure from the union's LM-2 that are political/advocacy in nature, including advocacy and political activities that are not necessarily tied to a registered political committee, but are clearly designed to influence public debate.

Wasteful Spending

We have compiled the LM-2 forms for all seven unions from 2017-2024 (last available year for all unions). 2017 was used as it marked the beginning of President Trump's first term. The disclosure of union spending on these forms is broken down under five categories that include general overhead, union administration, representative activities, contributions/gifts/grants, and political activity. These spending categories (golf outing as general overhead) are often misleading, so we have created seven new classifications that more accurately describe union spending. New categories for spending are listed as follows, entertainment, food and beverage, hotel and conference, legal, political spending, swag, and travel.

Categories

Entertainment – Parties, amusement parks, recreational events/activities, as well as sports ventures and venues

Food and Beverage – Restaurants, drinks, fast food, and catering

Hotel and Conference – Resorts, hotels, conferences, banquets, and event venues

Legal – lawyers, law firms, arbitration, and any legal expenses

Political Spending – Advocacy, ideological organizations, candidates, committees and all expenses the union labels as political activity

Swag – Watches, jewelry, t-shirts, gifts, printing, and any merchandise purchased by the union

Travel – Airlines, travel expenses, and travel agents



Political Spending Undermining MAGA Policies

SMART's political spending (union funds and from its PAC) heavily favors Democratic committees, organizations, and candidates. The union's spending from its PAC and through union funds is heavily biased towards Democrats.

\$35,000,000 on Left-Wing Political Activities

From 2017 to 2024, SMART has spent over \$35,000,000 on political activism/advocacy.¹ Most of this money went to SMART associated PACs, left-wing organizations, and various labor councils that conduct political advocacy. SMART also contributed to various left-wing political candidates and spent \$150,000 to stop the recall of California Governor Gavin Newsom.

No spending to Republican groups could be found, but the union has donated over \$1,000,000 to a variety of Democratic party groups in the United States.²

Jobs With Justice – Left-Wing Activist Group Fighting Back Against ICE

Blue Green Alliance – Left-Wing Climate Group Focused on Racial and Economic Inequality

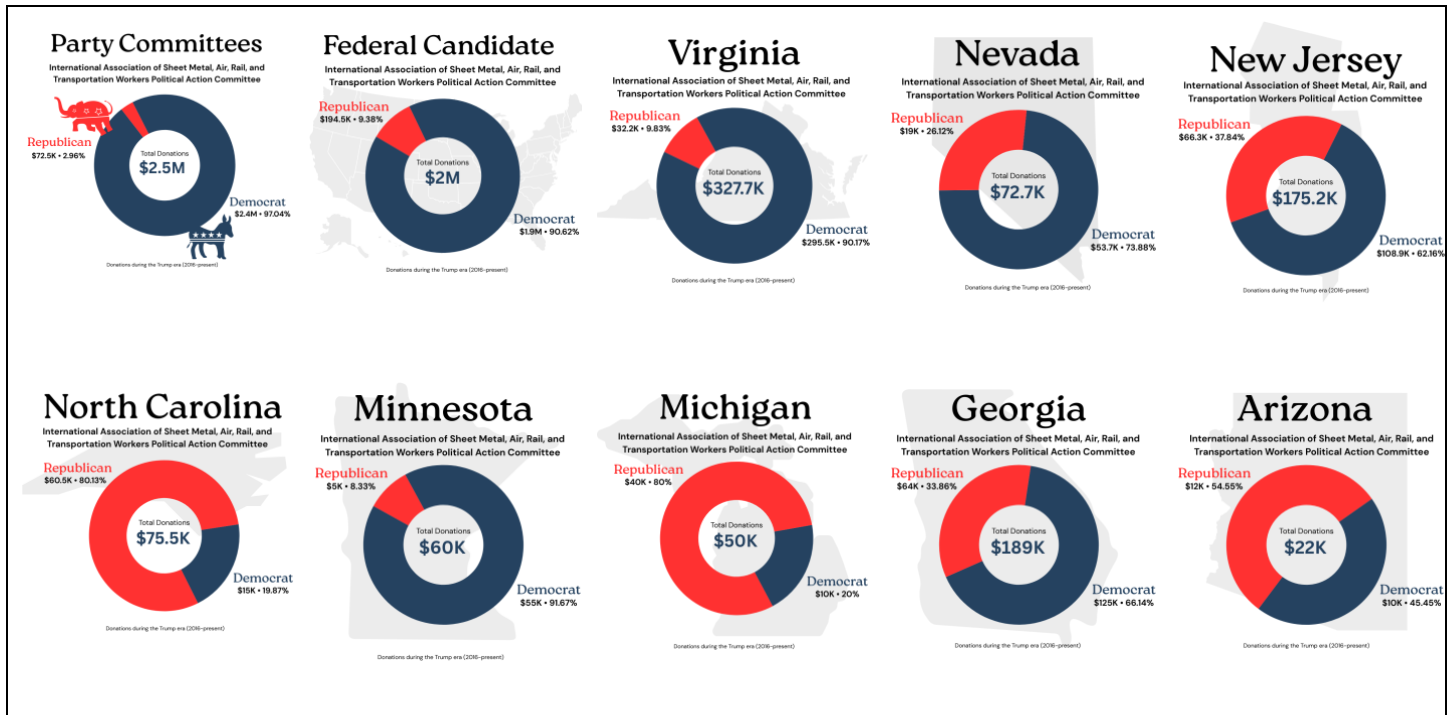
The Blue Green Alliance was formed by the United Steelworkers and Sierra Group and focuses on uniting labor with environmental organization to fight climate change and stand against economic and racial inequality.⁶

The United Steelworkers and the Sierra Club formed the BlueGreen Alliance (BGA) in 2006 in recognition that the future of working people and the health of the environment are inextricably linked, rejecting the false choice that good-paying jobs and economic opportunity are at odds with protecting our environment.

BGA unifies labor unions and environmental organizations into a powerful force to fight climate change, protect the health of people and the environment, stand against economic and racial inequality, and create and maintain good-paying, union jobs in communities across the country.

The Blue Green Alliance is one of many environmental organizations that is funded by SMART union funds.

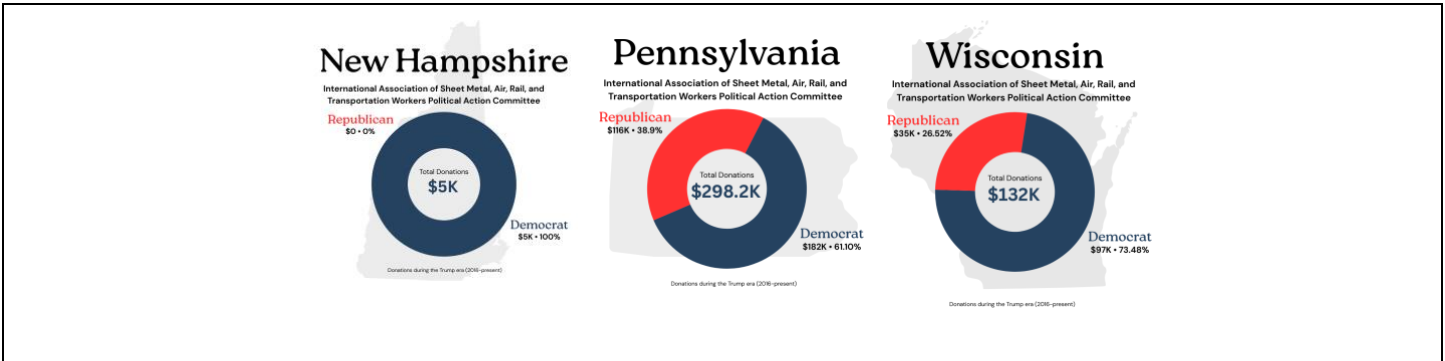
IA-SMART’s Political Spending Reflects Clear Alignment with Democratic Leadership

Since the beginning of the Trump era when examining both party committee and federal candidate disbursements, IA-SMART’s Political Action League demonstrates a pronounced and sustained directional preference. Specifically, the committee directed \$2,375,500.00 to Democratic party committees compared to \$72,500.00 to Republican committees, which translates to 97.04% of committee dollars flowing to Democrats and 2.96% to Republicans.

Even more telling, at the federal candidate level, IA-SMART provided \$1,878,000.00 to Democratic federal candidates, whereas only \$194,500.00 went to Republican candidates. In percentage terms, 90.62% of federal candidate dollars were directed toward Democrats and just 9.38% toward Republicans. Stated differently, for every dollar directed to a Republican federal candidate, approximately 9.66 dollars were directed to a Democrat. When viewed in aggregate, and particularly in light of the magnitude of federal spending, the allocation pattern is demonstrably partisan.

To be sure, three states show a Republican majority at the state level. However, those outliers represent only a small slice of IA-SMART’s aggregate political expenditures. In the states and federal contests that materially shape congressional control, the dominant flow of funds favored Democrats.

Further reinforcing this orientation, the PAC's largest disbursement targets consist primarily of core Democratic political infrastructure entities.

- EMILY'S LIST received \$1,030,000.00; ⁷
- INDIANA DEMOCRATIC PARTY received \$360,000.00; ⁸
- UNITE THE COUNTRY (Biden/Harris PAC) received \$240,000.00; ⁹
- WOMEN VOTE! (EMILY List IE Arm) received \$237,500.00; ¹⁰

In context, these high-dollar disbursements represent institutional investments rather than isolated transactions, thereby underscoring a broader strategy aligned with Democratic congressional and national leadership priorities.

Independent Expenditures Maintain the Same Directional Preference

Although IA-SMART's independent expenditure activity is relatively modest in scale, totaling \$165,000.00 during the reviewed cycles, the directional consistency is absolute. Each reported independent expenditure supported Democratic candidates or opposed Republican candidates. Even where spending volume is limited, the partisan orientation remains uniform and aligned with the PAC's hard-dollar allocation pattern.

Political Donations from Leadership

SMART's leadership has a history of biased FEC donations with no donations going to Republicans.

Opposing Trump Immigration Policy

Support for MS-13 Gang Member

In 2025, SMART General President Michael Coleman and the SMART union issued a statement in support of the alleged MS-13 gang member, Kilmar Abrego Garcia. Garcia has been locked in a battle with the Trump Administration over the administration's attempt to deport him from the country.²²

"In August, Kilmar Abrego Garcia saw his family for the first time in months, after he was first illegally deported to El Salvador, and then held in custody after he returned to the United States," Smart-TD General President Michael Coleman said in a statement after U.S. District Judge Paula Xinis's ruling.

"Days after he reunited with his wife and children, Kilmar followed the law and attended a mandatory check-in with Immigration and Customs Enforcement," ICE, said Coleman. "He was immediately detained. He has not been with his family since.

"It is almost impossible to imagine what Kilmar, his wife, Jennifer, and his young children have experienced over these months.

“But today, after even more months of separation, Kilmar and his family have finally been given the chance to see each other again. We are thankful this family will finally be reunited.

“The fight for Kilmar has always been about due process. It is one of the pillars this great country was founded on. A pillar that actually DOES make America great. We fight for this due process every day for our members, and we will continue to fight for it and every right that our members deserve,” Coleman promised.

President Michael Coleman defended Abrego Garcia on CNN in April 2015 and claimed there was no proof Garcia was a part of MS-13.²³ [Video Included in Link]

Endorsement and Support of Democrats

Praised “Unprecedented Accomplishments” of Biden Administration

After the 2024 election, SMART praised the Biden Administration for its “unprecedented accomplishments.”²⁵

On the morning of Wednesday, November 6, Donald Trump won his bid for reelection to the White House, defeating Vice President Kamala Harris and Minnesota Governor Tim Walz.

The American people have spoken, and SMART stands ready to work with elected leaders to advance the interests of members and their families.

SMART endorsed the Harris-Walz ticket based on both candidates’ strong, pro-labor records and their plans to build on the unprecedented accomplishments of the Biden-Harris administration.

President Biden’s term in office will be looked back on as one of the most pro-worker administrations in modern history. For SMART members, specifically, the Biden-Harris administration’s passage of the American Rescue Plan, the Bipartisan Infrastructure Law, the Inflation Reduction Act and the CHIPS and Science Act saved union members’ pensions and created thousands upon thousands of union jobs. And the Federal Railroad Administration’s two-person train crew rule finally prioritized safety and SMART-TD railroaders’ jobs over Wall Street profit.

Despite an inflation crisis and wretched job approval numbers, SMART referred to the Biden-Harris Administration as the most “pro-worker” administration in modern history.

Hillary Clinton Endorsement

In 2016, SMART endorsed Hillary Clinton and supported a #SheWillFixit campaign.²⁶

For months now, coverage of Donald Trump and Hillary Clinton has saturated our nation’s news coverage. And thanks to Trump’s ability to swamp the media with the insults he hurls and gaffes he makes, that coverage is too often light on substance.

Not enough is being reported on or shared with voters about the stark differences between the candidates on major issues that affect our economy — including the state of our transportation infrastructure. We hardly hear a word in the news coverage about what Clinton and Trump will do about suffocating commutes, aging infrastructure, choke points in our freight network and technology upgrades waiting to be deployed. Disparaging comments aimed at major swaths of our populations, apparently, sell more TV ads.

Today, the AFL-CIO’s Transportation Trades Department (TTD) is hoping to change that with the launch of their new campaign #SheWillFixit. Their goal is to educate working people in transportation, and those who care about the quality, reliability and safety of our transportation system, about the candidates’ plans to fix our aging transportation system. Hint: that should be literally everyone.

SMART's Democratic bias is all too telling when it inserts quotes like "This initiative isn't about making Donald Trump look bad – he does that quite well all on his own."

Hosted Tim Kaine Rally Where He Claimed Trump is a Tax Cheat

In 2016, SMART Local 19 hosted a rally with VP candidate Tim Kaine.²⁷

Fresh from the vice presidential debate, Democratic candidate and Virginia senator Tim Kaine spoke at a rally at Local 19 in Philadelphia where he spoke about his and Hillary Clinton's economic vision for America.

Speaking about Donald Trump's possible failure to pay taxes like other Americans, Kaine noted that it "makes me very, very angry" since he knows first-hand with his own son currently serving in the Marine Corps the sacrifices that American troops make and the support Trump denies them.

Referring to the \$916 million loss Trump claimed on his 1995 taxes, Kaine noted "I guess it takes a lot of genius to lose a billion dollars." He asked if "this is the kind of genius you want running the whole American economy? You got to be kidding me."

Motivating the standing room only crowd of union members and Philadelphia activists, the son of a union iron worker reflected that "It's close. Just eight days ago it was even. It looks pretty good now, but I'm not sure what's going to happen in the next eight days."

"In every election, I put this thought in the back of my head — that I'm the underdog until I win it," Kaine said. "That's how you have to run every race."

In the speech, Kaine accused Donald Trump of failing to pay taxes.

SMART Leadership Gets Front Row Biden Seats

In 2020, SMART leadership supported Joe Biden by sitting in the front row of a campaign event.²⁸

SMART representatives had a front-row seat as Democratic presidential candidate former Vice President Joe Biden spoke Oct. 24 at Bristol Community College in Bristol, Pa.

SMART-TD New Jersey State Legislative Director Ron Sabol and Gregg Weaver, a retired TD Local 838 member and former Local 1390 officer who served as a conductor for many Amtrak rides taken by Biden, were in the front row at the "drive-in" rally that was broadcast live on CNN from the town outside Philadelphia.

“What we heard from Joe Biden today was a concrete plan,” Sabol said. “He has a strategy to address the virus. He has a plan to repair the economy. He has ideas and has a strategy to make things better going forward with a focus on transportation and infrastructure.”

Weaver, who worked the rails on both the passenger and freight side with Conrail for 42 years, said Biden has proven his concern for the working people. Weaver’s son, Blake, a Local 838 member, followed in his father’s path and has been an Amtrak conductor for more than 16 years.

SMART’s legislative director responded to Biden’s speech by saying he had a “concrete” plan on handling coronavirus.

Formal Endorsement of Joe Biden's 2020 Campaign

In 2020, SMART made formally endorsed Biden in a long piece criticizing the Trump Administration.²⁹

I'm very concerned about Donald Trump, should he be elected as our next President. He has repeatedly said he will discard regulations and get rid of government bureaucracy. During this tumultuous presidential campaign, there have been persistent claims that suggest we are at risk of losing our Second Amendment rights if Hillary Clinton is

In fact, this issue was discussed during the recent debate, when both candidates, Trump and Clinton, agreed that they would 'try to get the guns out of the hands of people that should not have them' i.e., criminals that should not be able to legally purchase a gun, according to existing laws. They both made similar comments regarding this issue.

Hillary has stated, as many others on both sides of the aisle have, that we need to have uniform laws in place to purchase and sell weapons, including a more thorough background check.

This does not, would not, and could not take away your Second Amendment rights, nor would it limit them. It simply strengthens procedures to ensure that those who qualify to own a weapon are allowed to do so, and those who do not qualify, cannot obtain one.

Donald Trump, despite his NRA endorsement, has flip-flopped several times on gun control.

As Trump supporters know, the contention that Hillary would have been a better advocate for the second amendment was laughable then and even more outrageous now.

Supported UAW Lawsuit Against Trump Administration

In 2024, SMART supported a UAW lawsuit against the Trump Administration.³⁴

Trump expressed his profound admiration toward Musk, who emulates Trump's trademark "You're fired" reality act from "The Apprentice" in real life. The two discussed casually devastating people's careers and families' incomes, then laughed about it.

The UAW has already filed suit against both Trump and Musk for unfair labor practices. We support that action. The UAW, because Musk owns Tesla and SpaceX, has legal standing since they're working to organize workers there. We do not. Otherwise SMART would be right there with them.

The frivolous lawsuit was over comments made about firing striking workers at Tesla.

Opposed Firing of Democratic Board Member

In 2025, SMART-TD called President Trump's decision to oust a Democratic Surface Transportation Board member "nothing short of outrageous."³⁵

President Donald Trump has fired one of two Democratic members of the U.S. Surface Transportation Board to break a 2-2 tie before the body considers the largest railroad merger ever proposed.

Board member Robert E. Primus said on LinkedIn that he received an email from the White House Wednesday night terminating the position he has held since he was appointed by Trump in his first term. The vacancy would allow Trump to appoint two additional Republicans to the board before its decision on the Union Pacific-Norfolk Southern merger though the Senate would have to confirm them.

"The explanation provided for this decision — that his position has been "eliminated" — is nothing short of outrageous. Appointed bodies established through federal code are not designed to be erased at the whim of powerful corporate interests," said the SMART-TD union that represents conductors. "This action is unprecedented, unlawful in spirit, and reeks of direct interference from hedge funds and the nation's largest rail carriers."

SMART-TD's opposition to firing an anti-Trump Democratic bureaucrat shows how deeply partisan the union is.

2016 Declaration Blasting Trump

In 2016, then VP of the Smart Transportation Division blasted President Trump and claimed he would have botched the Cuban Missile Crisis. ³⁶

Donald Trump has demonstrated time and time again throughout this campaign that he would not have exercised the same self-control as President Kennedy did in 1962. He lashes out immediately in response to every threat, real or perceived, and tries to justify his reaction later through subordinates. Recently he threatened, "I'll blow them out of the water" if Iranian boats circled our destroyers and made inappropriate gestures. Really? Does the U.S. really want to trigger a war costing thousands of U.S. lives over inappropriate gestures? Apparently a President Trump would. It's sincerely scary.

Also, forget about your guns. There have been several Democratic presidents and not one has taken away your hunting rifles. Forget about abortion, Roe vs. Wade has been here since 1973 and is not likely to change during this president's term, nor is the president likely to change anyone's feelings on the subject. When you strip away all of the peripheral political pundit buzz, the bottom line is Donald Trump is unstable, dangerous, and clearly governed by his own ego. If there's even a slight chance that his irrational and impulsive decisions can trigger an unnecessary war or, God forbid, a nuclear conflict, are you willing to take that chance? Claimed Retirement Funds Were at Risk from Trump

SMART TD claimed union workers “retirement was at risk” if Donald Trump won the 2024 election.³⁷

The Washington Post article highlights a stark reality: “Compared to prior presidential campaigns, I can’t think of anything that would be this order of magnitude in its detrimental effect on Social Security’s bottom line compared to the policies Trump has proposed,” Marc Goldwein, senior policy director for Committee for a Responsible Federal Budget, told the newspaper. These proposals, which include massive tax cuts for business owners and corporate bailouts, threaten to deplete the very retirements our members have diligently built.

As the report outlines, the potential consequences are severe: “All added up, the report forecasts that Social Security under Trump would hit the point where by law it must cut benefits in 2031 or 2032,” leading to a “reduction for all Social Security checks to a predicted cut of about 33 percent.”

For the workers and retirees dependent on Social Security, this translates to a significant and devastating reduction in the retirement income they expect and deserve after years of dedication and service to the public and to this union.

SMART-TD is not in the business of accepting agreements from transit agencies or railroad companies that give our members a 33% pay cut. It is unacceptable for our active members, and it is unacceptable to accept this for the nation’s retirees!

This situation represents a shocking abuse of the American worker, particularly for our SMART-TD brothers and sisters. The threat to Social Security is not just an economic issue. For SMART-TD, it is a moral one. Our members deserve what they have worked for, and it is our responsibility to stand against the policies of any employer, and in this case, any presidential candidate, that jeopardizes that security.

As we move forward as a union, we must remain vigilant in advocating for the protection and enhancement of Social Security. It is crucial that we amplify our voices and demand that the rights of all workers are upheld. The future of our retirement security is at stake, and together, we can fight to ensure that our hard-earned benefits are preserved for generations to come.

As of 2026, there has been no discussion of the Trump Administration cutting social security benefits.

Documented Long List of Trump Administration’s “Anti-Worker Actions”

In 2025, SMART listed just one “pro-worker action” compared to 22 “anti-worker” actions on its website.³⁸

SMART is committed to keeping members informed about actions that impact our jobs, livelihoods and families. The SMART Governmental Affairs and Communications Departments are tracking executive actions that affect members — positively and negatively — and will continue to do so moving forward. This list was last updated April 10, 2025.

1. President Trump nominated former Oregon Republican Rep. Lori Chavez-DeRemer as secretary of the Department of Labor. Chavez-DeRemer built a pro-worker record in Congress, voting for bipartisan legislation like the Protecting the Right to Organize (PRO) Act and National Apprenticeship Act. Chavez-DeRemer was confirmed to lead the DOL in March.

Anti-worker actions:

1. President Trump fired National Labor Relations Board General Counsel Jennifer Abruzzo and board member Gwynne Wilcox. These firings cast out a pro-worker champion at the NLRB who advanced SMART members' rights (banning captive audience meetings, for example) and made it so the NLRB couldn't meet to oversee union organizing elections or hear cases about employers breaking the law.
2. President Trump canceled government support for wind energy projects, putting construction on hold and forcing contractors and local unions to look elsewhere for work.
3. Trump's Environmental Protection Agency has canceled \$20 billion in loans for building retrofits and other energy efficiency projects that would create good jobs for SMART members.
4. President Trump revoked an executive order that implemented the Inflation Reduction Act and directed federal agencies to focus on creating good-paying union jobs. To date, the labor standards in the Inflation Reduction Act have created thousands of jobs, with projects paying prevailing wages and providing opportunities for hundreds of SMART apprentices.
5. President Trump revoked an executive order implementing the Bipartisan Infrastructure Law; the order had prioritized creating jobs with high labor standards where workers have the chance to join a union.
6. President Trump revoked an executive order that implemented the Inflation Reduction Act provisions on Medicare negotiation of lower drug prices.
7. President Trump and Elon Musk's Department of Government Efficiency (DOGE) fired thousands of federal workers who provide needed healthcare to veterans and ensure seniors receive the Social Security payments they earned.
8. President Trump issued an executive order directing agencies to disapprove finalized union contracts signed within the last 30 days of the Biden administration.
9. The Trump administration's Federal Railroad Administration granted 22 waivers to Genesee & Wyoming Railroad subsidiaries, including the Heart of Georgia Railroad and Georgia Central Railway, to begin testing autonomous freight rail cars — despite SMART-TD raising concerns about safety (prototypes failed several critical safety tests) and members' job security.
10. The Trump administration's Office of Management and Budget Director Russell Vought is currently trying to shut down the Consumer Finance Protection Bureau, a law enforcement agency formed after the 2008 financial crisis to protect American consumers from financial institutions allegedly practicing dishonest or illegal activity. The CFPB has returned over \$13 billion to millions of Americans who have fallen prey to financial scams.
11. The Trump administration's Department of Defense ended the use of project labor agreements on "large-scale construction projects," taking away work from union members and signatory contractors.
12. The Trump administration's then NLRB Acting General Counsel William Cowen made captive audience meetings, a key tactic for bosses looking to scare workers into voting against a union, legal again after they had been banned by the previous NLRB general counsel.
13. President Trump, in a joint address to Congress, called for the cancellation of the CHIPS Act, which is creating thousands of jobs for SMART members on semiconductor manufacturing projects from Arizona to Vermont.

14. President Trump's Department of Homeland Security canceled the collective bargaining agreement between the Transportation Security Agency and TSA officers, leaving 47,000 TSA officers without representation.
15. The Trump administration's Department of Education fired half of its staff, including those in charge of workforce development programs that direct students into the trades. These cuts will make it harder for children with disabilities to get the education they deserve. President Trump later signed an executive order directing Education Secretary Linda McMahon to dismantle the department.
16. President Trump and Elon Musk's DOGE announced the closure of Railroad Retirement Board field offices across the country, compounding the already unacceptable delays and wait times rail workers experience when attempting to contact or get information from the RRB. Additionally, President Trump's executive orders made it so the RRB can only hire one employee for every four who leave, adding onto the capacity issues the under-funded board already faces.
17. President Trump repealed previous executive orders that promote registered apprenticeships on infrastructure projects, handing an early win to nonunion contractors. The Trump White House said the order, which leveled the playing field for SMART contractors and apprentices, was "forcing radical labor policies and apprenticeship mandates onto American businesses and government agencies."
18. President Trump picked Crystal Carey, a lawyer at the notorious union-busting law firm Morgan Lewis, to head the National Labor Relations Board. Carey's biggest recent client was Amazon.
19. As part of the U.S. Housing and Urban Development Department's DOGE-directed downsizing, HUD is closing the Office of Field Policy and Management, which enforces prevailing wage and anti-discrimination laws that protect SMART construction workers; 150 field staff have been let go as of Friday, March 21.
20. Following the directions of President Trump, DOGE moved to dismantle the Federal Mediation and Conciliation Service, a small agency that supports unions and employers throughout the collective bargaining process and helps to resolve work stoppages. The kneecapping of the FMCS, which makes up 0.0014% of the U.S. budget, could result in longer work stoppages, prolonged contract negotiations and more.
21. President Trump issued an executive order that stripped union rights and collective bargaining from more than 700,000 federal workers, including those who take care of veterans and work in border security, among many others. This undermines the bedrock principles of collective bargaining our nation was founded on, and that SMART members rely on when bargaining every union contract.
22. Trump Energy Secretary Chris Wright directed the National Laboratory Operations Board to "assess the benefits and risks of removing construction labor agreement provisions from National Laboratory contracts" — a clear step away from decades of project labor agreements that benefit SMART members on National Laboratory work.

The long list of complaints chastises President Trump for cutting wasteful spending on excessive bureaucrats and wind energy.

SMART Protecting Predators

SMART has employed a criminal in its leadership ranks who has a criminal record that includes burning a cross in a black families front yard, a crime for which he received 30 months in prison.

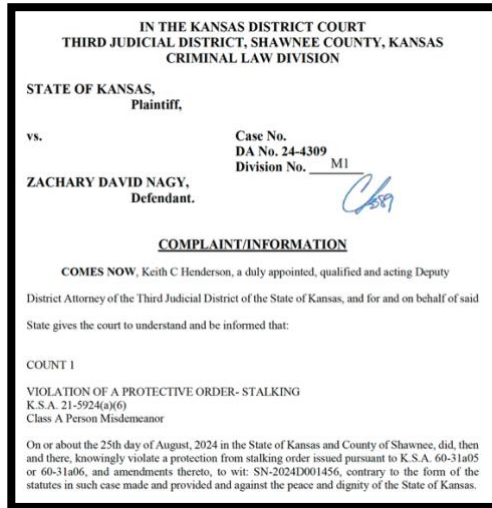

Prior Arrest History

Nagy's prior arrest history shows he has been arrested for disorderly conduct, criminal discharge of a firearm, theft, aggravated robbery/kidnapping, criminal deprivation, aggravated assault, violation of civil rights, and conspiring against rights of citizens.⁴²

"I had (police) Sgt. (Mike) Garnett knock on my door and tell me, 'Mr. Anderson, on behalf of the citizens of Augusta, I want to apologize for this.' That meant a lot to me. That same day, one of the firemen came by and did the same thing."

Within hours of the Andersons' discovery of the cross, police arrested Zachary David Nagy, 20, and Virgil Fry, 16, both white and of Augusta. They remain in custody in the Butler County jail in El Dorado.

A preliminary hearing for Nagy and Fry is set for Wednesday.

"Our stance on this is very clear — we're not going to tolerate it," said Augusta director of safety David Pate. "As soon as we found out what happened, we pulled out all the stops. We put it on our CrimeStoppers cable channel here and the response was overwhelming."

The arrests didn't surprise Pate.

"As anybody in law enforcement will tell you, we deal with about 2 percent of the population about 80 percent of the time. That's what we're dealing with here."

According to Anderson, his youngest daughter, Courtney, was with a group of mostly black youngsters who were approached June 15 by a group of mostly teen-age white males outside the Anderson home,

which is one block from the municipal swimming pool. Both groups moved to the nearby park where more words, including racial slurs, were exchanged.

Someone called police and both groups were dispersed. A day and a half later the cross was in the Anderson's yard.

"Burning crosses in people's yards is not acceptable in Augusta," said the Rev. Robert Box of the First Baptist Church in Augusta.

"In a way, I think this whole incident reflects well on the city of Augusta because people have pulled together to make clear that this is not who we are.

We don't have room for this in our community."

The Andersons happened to attend First Baptist Church last Sunday.

"I apologized to them publicly from the pulpit," Box said.

Anderson said he hasn't been sleeping well lately. He's not used to being in the spotlight, and he's having trouble balancing the anger over someone burn-

ing a cross in his yard with rewards of living in community that cares.

But he's not interested in revenge.

"We are a Christian family," Anderson said. "We will not judge the people who did this; God will do that. I'm just glad it's over and that our house didn't catch on fire."

WICHITA — A 20-year-old white man accused of burning a cross on a black family's yard was sentenced to more than two years in federal prison, U.S. Attorney Jackie Williams said.

Zachary David Nagy was sentenced to 30 months in prison on Thursday by U.S. District Judge Wesley Brown. He faced a maximum of 10 years in federal prison.

Nagy pleaded guilty on Oct. 15 to conspiring to violate the civil rights of a person.

Nagy and Virgil Fry Jr., also of Augusta, were accused of burning the cross after it was found June 17 on the property of Joe Anderson, who shares his home with his wife and two daughters. Fry is also white.

The burning followed a weekend argument at a city park among four to six youths, including friends of the Anderson family, said David Pate, Augusta's director of safety.

Fry, who was 16 at the time of the burning, was charged in June as an adult with criminal threat in Butler County Court, Butler County Attorney Michael Ward said.
